 (Gently) peels the cast(s) off once the plaster has softened May need to use bandage scissors with a blunt tip to cut the plaster cast if it is thick in areas. 		
• Disposes of casting material in the trash can and disposes of dirty water		
Rinses the tub and refills it with clean bath water and soap		
Bathes the baby to ensure skin is clean and free of casting material
